- 1. I agree that I and my assignees, heirs, distributees, guardians and legal representatives (hereinafter "Representatives") will not sue, make claim against or attach the property of the Community or the Community's directors, officers, members, employees, agents or any other person acting on behalf of the Community (all such individuals hereinafter shall be referred to as "Agents") for any injury or damage resulting from my participation in the Workshop.
- 2. I also release the Community and the Community's Agents from all actions, claims or demands that I or my Representatives now have or may later have for injury or damage resulting from my participation in the Workshop.
- 3. I further agree to accept responsibility for any injury or damage resulting from my participation in the Workshop. As used in paragraphs 1 through 3, the terms injury and damage refer to any injury, death or property damage resulting from my participation in the Workshop. This includes injury or damage resulting from the negligence or other acts of the Community or the Community's Agents, and also includes and injury or damage resulting from any food, lodging or transportation provided to me by the Community or the Community's Agents.

I have carefully read this agreement and fully understand its contents. I am aware that this is a release from liability and a covenant not to sue, and I have signed it of my own free will.
